The town will display entries at Burns Park on Sunday, December 12, 2021 at the Holiday Event and residents will have the opportunity to vote on their favorite entries. We do not want to limit your creative abilities to only gingerbread houses. You can choose to construct a gingerbread castle, house, toy store, etc.; however, we do have space limitations for entries which are listed below under the rules and regulations. We invite everyone to participate, be creative, and have fun with their entries!

Rules and Regulations

- All entries must be minimum five foot (5ft.) up to ten foot (10 ft.) height, minimum five foot (5ft.) up to ten foot (10 ft.) length, minimum five foot (5ft.) up to ten foot (10 ft.) width when fully constructed.
- All entries must be gingerbread/holiday themed and must be family-oriented in nature. Entrants are encouraged to use lights; however, entrants will need to provide a power source for their entries (no electricity will be available). Advertising is permitted, but the theme should be the focus of all entries.
- Characters and themes are encouraged and entrants may dress up and hand out candy or visit with guests during the event; however, there is only one (1) Santa and the Town has already scheduled him to visit the park. As such, Santa costumes will not be permitted with entries.
- Entrants will be assigned a number and are permitted to set up in their designated space as early as 10:00 a.m. on Sunday, December 12, 2021, but must have entries fully set-up and constructed no later than 4:30 p.m.
- Entrants are responsible for all construction and tear down of their entries. Entries must be taken down no later than December 13, 2021 at 10:00 p.m. when the park closes. Entrants may also choose to sell their entries during the event, but will be responsible for the sale and ensuring the entry has been removed from the park by this deadline.
- The town will have a stage set up in the park the day of the event and will be providing music. As such no music will be permitted for entries.
- In the event of unsatisfactory weather conditions, the event will be cancelled. Any cancellation notifications will be made as soon as possible on the day of the event
- The town will designate and post a time in which all voting will cease and winners will be determined and announced.
- All entrants are required to submit an application no later than Wednesday, December 8, 2021. All applications must be submitted either in person or by emailing to Parks Director Brandy Miniati at bminiat@kingstonsprings-tn.gov by close of business on this date.
